Application for a Parish Council Grant

Who is eligible?

• Local voluntary or charitable groups (clubs, societies and organisations) based and/or working within the parish of Barwell.

The work of the group should benefit some or all of the residents of Barwell.

Who is not eligible?

- Organisations intending to support any particular political party or to discriminate on the grounds of race or religion
- Profit or surplus making private businesses
- Public and private limited companies
- Local groups whose fund raising is sent to their central HQ for redistribution

What can grants be used for?

- Capital cost of new or improved facilities or equipment
- Providing a public service
- Supporting a specific event
- Improving the environment
- Enhancing quality of life

How much do you grant?

Grants of between £50 and £500 will be considered

Who makes the decision and when are grants given?

- Applications are considered by the Parish Council's Finance Committee
- Grants are awarded quarterly (March, June, September and December). The deadlines for applications are as follows:
 - 15 February
 - 15 May
 - o 15 August
 - o 15 November
- Each application will be assessed on its own merits and will be considered along with other applications at the meeting.

What are your conditions?

- The committee's decision is final and there is no scope for reconsideration
- If you have been successful in the past, you cannot re-apply until 12 months have passed
- Further details may be required such as
 - o details of membership
 - location of the group
 - o Age range of the members where appropriate.

This list is not necessarily exhaustive.

• The offer of grant will be publicised in some form by the Parish Council
