Reasons:

- Barwell urgently needs a new burial ground and the land in this application has been found to be suitable
- The land allocated to Barwell SUE and the proposed Solar farm, land for a new burial ground is very limited
- This development is in the Green Wedge which separates Barwell from Hinckley and is our "Green Lung"
- Two previous application to build in the Green Wedge have been rejected at appeals in the past
- Burial grounds ARE permitted on the Green Wedge
- The SUE will provide many houses therefore the need for the burial ground is far greater than houses to our
- DM17 Highway Safety Hinckley Road is already a busy route out of the village and a sustainable traffic calming scheme and improvements to the junction of A447 is now needed. Another 25 plus cars will make this road very
- Hinckley Road floods near to this site and with increasing heavy rainfall with 25t extra paved drives and patios will the SUDS scheme on this development cope and will it be maintained in the future
- Land not within site allocation DPD or Area Action Plan
- Does not demonstrate it will significantly contribute to economic growth or job creation and/or diversification of rural businesses to Barwell
- Conditions of the original application state that the land should be gifted to Barwell Parish Council for Cemetery
